BUFFALO FIELD CAMPAIGN COMMENTS ON HB 495 - DO NOT PASS

Mr. Chairman and members of the House Fish, Wildlife, and Parks committee,

On behalf of Buffalo Field Campaign I am submitting testimony on HB 495. Mr. Chairman, I request that my testimony be entered into the hearing record. Thank you.

HB 495 mandates Montana Fish, Wildlife & Parks post a \$5,000 bond for each wild buffalo sold or transferred by the Department of Livestock under MCA 81-2-120 and released, transplanted or allowed under MCA 87-1-216.

HB 495's requirement for the posting of a \$5,000 bond for each wild buffalo affected is "to insure the payment of damages caused" to public and private property on public and private lands "where the presence of the animal is not authorized."

By establishing Fish, Wildlife & Parks' liability for the behavior and acts of wild buffalo an uncertainty is raised in how HB 495 impacts Montana's eligibility to participate in the Wildlife and Sport Fish Restoration program. Impairment of Montana's eligibility to participate in the restoration program is a question for the committee.

Why is a legislative exception being carved out of long held precedent in Montana to make the state liable for damages caused solely by wild buffalo?

Will the legislature next propose that owners of fruit trees be compensated for the fruit taken by migratory birds?

HB 495 begs the question: should the state of Montana be held liable for all of the grass eaten by native rabbits in a livestock rancher's field?

HB 495 would have you ignore and go along with undermining long-held Montana Supreme Court precedent finding that wildlife species do not "belong to any owner" and the state cannot be held liable for acts or the behavior of wildlife. (Please see BFC's attached HB 495 handout on Montana and U.S. court precedent on this issue).

In Rathbone v. Montana (1960) the Montana Supreme Court found that a property owner in Montana:

"... must recognize the fact that there may be some injury to property or inconvenience from wild game for which there is no recourse."

This long-standing precedent was recently affirmed in Park County Stockgrowers Association v. Montana (2013) by Judge E. Wayne Phillips who wrote:

"Montana's Constitution contains no provision safeguarding against threats to personal safety caused by naturally occurring conditions such as native wildlife. To the contrary, Montana's Constitution, laws, and regulations provide special considerations to assure that our wild places and the creatures that inhabit them are preserved for future generations."

HB 495 is not a win-win bill. If HB 495 is adopted into law, liability of damages for acts of wild buffalo will be a liability imposed on Montanans in perpetuity.

HB 495 is not amendable. We encourage the committee to not pass HB 495. Thank you for your consideration.
