
YELLOWSTONE BISON POPULATION MANAGEMENT ACTIVITIES

This report summarizes management activities associated with implementation of the Record of Decision for the Final Environmental Impact Statement and Bison Management Plan for the State of Montana and Yellowstone National Park for the time period 1 October 2005 through 30 September 2006. The reporting period for this summary is **05 May through 01 June 2006.**

The next report will be distributed in July and will include a preliminary post-calving population estimate.

PARKWIDE DISTRIBUTION:

Distribution information is provided by ground-based surveys conducted by biological field technicians of the YNP Bison Ecology and Management Office.



Red points illustrate the location of a park-wide representative sample of marked individual bison.

General Trend: Bison continue to move into the Hayden and Lamar Valleys.

MANAGEMENT ZONE COUNTS:

HAZING OPERATIONS:

Hazing operations that occur near the North and West Boundaries are primarily conducted and reported by the YNP Division of Resource Management and Visitor Protection and MT Department of Livestock respectively.

North Boundary Area: 4 hazing events were reported.

5 May 2006: **35** mixed age/sex class bison were hazed from the boundary at Reese Creek to near Chinese Gardens, south of the North Entrance Kiosk.

- 5 May 2006: **52** mixed age/sex bison were hazed from Rifle Range Flats, east of the North Entrance Kiosk, towards Rescue Creek.
- 15 May 2006: **1** bull bison was hazed from outside of the Park on USFS land towards Powerline Flats, near the North Entrance Kiosk.
- 19 May 2006: 1 bull bison was hazed from near the Corwin Springs Bridge back into the Park.

West Boundary Area: 26 hazing events were reported.

- 10 May 2006: 42 mixed age/sex class bison were hazed into the Park from Horse Butte.
- 10 May 2006: **3** bull bison were hazed from Corey Springs, along Highway 287.
- 10 May 2006: 6 bull bison were hazed into the Park along Duck Creek.
- 10 May 2006: **24** bull bison were hazed into the Park from property near Duck Creek.
- 10 May 2006: 2 bull bison were unsuccessfully hazed into the Park from near Red Canyon.
- 11 May 2006: **60** mixed age/sex class bison were hazed into the Park from Horse Butte.
- 11 May 2006: **50** mixed age/sex class bison were hazed into the Park from the north rim of the Madison River, west of Highway 191.
- 11 May 2006: **15** mixed age/sex class bison were hazed into the Park from the north rim of the Madison River, east of Highway 191.
- 11 May 2006: **30** mixed age/sex class bison were hazed into the Park from south of the Madison River.
- 11 May 2006: 1 bull bison was hazed into the Park along Duck Creek.
- 11 May 2006: **3** bull bison were hazed into the Park from private property near Upper Bear Trap.
- 15 May 2006: 5 bull bison were hazed into the Park from private property near Upper Bear Trap.
- 15 May 2006: **19** mixed age/sex class bison were hazed into the Park along Duck Creek.
- 15 May 2006: **20** mixed age/sex class bison were hazed into the Park from the south Fork of the Madison River.
- 15 May 2006: **10** mixed age/sex class bison were hazed into the Park from the north rim of the Madison River.
- 15 May 2006: 1 bull bison was hazed from Corey Springs, along Highway 287.
- 15 May 2006: 3 bull bison were hazed into the Park from near Rainbow Point.

- 15 May 2006: 9 mixed age/sex class bison were hazed into the Park from Horse Butte.
- 16 May 2006: **19** mixed age/sex class bison were unsuccessfully hazed into the Park along Cougar Creek.
- 17 May 2006: **19** mixed age/sex class bison were hazed into the Park from the junction of Highways 287 and 191.
- 17 May 2006: 1 bull bison was hazed into the Park from property
- 18 May 2006: 9 mixed age/sex class bison were hazed into the Park from property.
- 19 May 2006: **10** mixed age/sex class bison were hazed into the Park from along the Madison River.
- 23 May 2006: 4 bull bison were hazed into the Park along Duck Creek.
- 23 May 2006: 8 bull bison were hazed into the Park from property.
- 23 May 2006: **23** mixed age/sex class bison were hazed into the Park from along the Madison River.

The following 7 hazing events occurred during the last reporting period.

- 3 May 2006: **92** mixed age/sex class bison were hazed from Red Canyon to the Park Boundary.
- 3 May 2006: 24 mixed age/sex class bison were hazed into the Park from Baker's Hole.
- 3 May 2006: **48** mixed age/sex class bison were hazed into the Park from the South Fork of the Madison River.
- 3 May 2006: **225** mixed age/sex class bison were hazed into the Park from Horse Butte.
- 4 May 2006: **38** mixed age/sex class bison were hazed into the Park along Duck Creek.
- 4 May 2006: **14** mixed age/sex class bison were hazed into the Park from Fir Ridge.
- 4 May 2006: 110 mixed age/sex class bison were hazed into the Park from Horse Butte.
